This Amendment No. 2 supplements and amends the Schedule 13D filed on April 6, 2021 and the Schedule 13D/A filed on May 11, 2021 by the Reporting Persons (as defined below) (as so amended, the "*Schedule 13D*"), relating to the common stock, par value \$0.01 per share (the "*Shares*"), of Playtika Holding, Inc., a Delaware corporation (the "*Issuer*" or "*Playtika*"). The Reporting Parties currently expect such potential sale to be approximately 15 to 25% of the total outstanding shares of the Issuer, however, the exact timing, manner and terms of any such sale, including the actual amount to be sold, would be subject to market conditions and other considerations.
